ABSTRACT

This report consolidates various data on the national debt; it presents changes and comparisons of the debt for the years 1955 to 1980. The report also contains information on the public debt limit, the ownership of the public debt, and the debt owed by several sectors of the economy.

DATA ON THE NATIONAL DEBT, 1955-1980

The public debt of the United States is as old as the Nation. In 1790 it was \$75.5 million; in 1835 it had been reduced to \$37.5 thousand. Since then the debt has risen rather steadily, falling rarely and jumping during wars. At the end of 1980 (calendar year) the gross Federal debt stood at \$936.7 billion.

In general, the term Federal debt refers to some combination of public and agency debt. Total outstanding Federal debt is called gross Federal debt (which comes closest to the popular concept of national debt) and consists of all outstanding public and agency debt. Public debt is the debt incurred when either the Treasury or the Federal Financing Bank (FFB) borrows funds directly from the public or another Federal fund or account. This constitutes the major portion of gross Federal debt. Agency debt is the debt incurred when a Federal agency, which is so authorized, borrows directly from the public or another Federal fund or account. Debt of federally-sponsored but privately-owned enterprises is not part of the Federal debt.

Three measures of Federal debt are commonly used: gross Federal debt (defined above); debt held by the public; and debt subject to limit. Federal debt held by the public, measures the portion of gross Federal debt held by the public, including the Federal Reserve System. This measure excludes Federal debt held by Federal trust funds, revolving funds, and off-budget Federal entities. Federal debt subject to limit, measures the amount of gross Federal debt limited by statute (the Second Liberty Bond Act of 1917, as

amended). This includes almost all public debt but only a small part of agency debt. This is the debt measure referred to in the periodic legislation to raise the debt limit.

Other measures and breakdowns of Federal debt exist and are readily available in the monthly Treasury publication, <u>Treasury Bulletin</u>. The economic and political issues of the national debt have been addressed in numerous publications including the CRS Report, <u>The National Debt: A Discussion of the Issues Involved</u> (Report No. 76-19E). The following tables present data on Federal debt from 1955 through 1980.

Note: The computed annual interest charge represents the amount of interest that would be paid if each interest-bearing issue outstanding at the end of the month or year should remain outstanding for a year at the applicable annual rate of interest. The charge is computed for each issue by applying the appropriate annual interest rate to the amount outstanding on that date. Beginning Dec. 31, 1958, the computed average rate is based upon the rate of effective yield for issues sold at premiums or discounts. Before that date the computed average rate was based upon the coupon rates of the securities. That rate did not materially differ from the rate on the basis of the effective yield. The "effective yield" method of computing the average interest rate on the rate on the public debt more accurately reflects the interest cost to the Treasury, and is believed to be in accord with the intent of Congress where legislation has required the use of the rate of effective yield for various purposes.
