## Supplemental Security Income (SSI): Benefit Changes for California Residents, 2006 and 2007

### Summary

California adds a supplement to the monthly benefit received by Supplemental Security Income (SSI) program participants in that state. Reductions in this state benefit in calendar years (CY) 2006 and 2007, and a suspension of the scheduled cost-of-living adjustment (COLA) to this state benefit will have the effect of offsetting increases to the federal SSI benefit and will result in smaller than normal increases to the total benefit paid to program participants in California. This report will be updated to reflect any policy changes.

### SSI in California

The Social Security Administration (SSA) provides benefits to persons who are aged, blind, or disabled and who have limited income and resources as part of the SSI program.<sup>1</sup> California, along with 44 other states, provides a supplement called the State Supplementary Payment (SSP) to this basic federal benefit provided by the SSA.<sup>2</sup> In California, this state supplement, along with the federal benefit, is administered by the SSA. As a result, SSI/SSP participants in California receive a higher total monthly payment than would be provided by the SSI program without the state supplement. As

is the case with all SSI benefits, the amount of the monthly SSI/SSP benefit is reduced by most types of earned and unearned income a participant has in a given month.

Each year, the amount of the federal SSI payment and the amount of the California SSP payment are increased to account for changes in the cost of living.<sup>3</sup> These COLAs go into effect at the beginning of a given calendar year.

## **Changes to SSI and SSP COLAs for 2006 and 2007**

For CY2006, the SSI COLA is set at 4.1%. As a result, the basic federal SSI benefit for a single disabled adult with no other income will increase from \$579 to \$603 per month whereas the benefit for a couple with no income will increase from \$869 to \$904 per month.

In July 2005, California Governor Arnold Schwarzenegger signed into law Senate Bill No. 68,<sup>4</sup> which, among other things, amended the Welfare and Institutions Code of California to reduce the total benefit that otherwise would be paid to SSI/SSP recipients in the state during CY2006 and CY2007. Specifically, this law includes the following two provisions that affect the total SSI/SSP benefit for a person living in California:<sup>5</sup>

- For CY2006 and CY2007, there will be no COLA for the state SSP payment and the SSP benefit is frozen at the CY2005 level;
- For the first quarter of CY2006 and the first quarter of CY2007, the state SSP payment will be reduced by an amount equal to that of the federal SSI COLA. However, this reduction will not be in effect for the remainder of the year. As a result, SSI/SSP beneficiaries in California will not see an increase in their SSI/SSP benefits until after April 1.<sup>6</sup>

## **Impact on SSI Beneficiaries in California**

In CY2005, a single aged or disabled SSI beneficiary living alone in California with no income received a total monthly SSI/SSP benefit of \$812. Of this amount, \$579 was paid by the SSI program, and the remaining \$233 was provided by the state SSP. In the first quarter of CY2006, this same single beneficiary will receive a total monthly SSI/SSP

benefit of \$812. Of this amount, \$603 will be paid by the SSI program, which includes the \$24 SSI COLA. The remaining \$209 will be provided by the state SSP, which reflects both the lack of any SSP COLA and the \$24 cut to this state payment that offsets the SSI COLA. After April 1, 2006, the state SSP will increase to \$233, bringing the total monthly SSI/SSP benefit payment up to \$836.

A married couple living together with no income received a total SSI/SSP benefit payment of \$1,437 in 2005. Of this amount, \$869 was paid by the SSI program, and the remaining \$568 was provided by the state SSP. A similar system of cuts will keep the total SSI/SSP payment for a couple at \$1,437 for the first quarter of 2006, increasing to \$1,472 after April 1. **Table 1** below summarizes these changes.

Although it is not known what the federal SSI benefit rates will be for CY2007, current California law provides for no SSP COLA during that year and a reduction in the SSP supplement equal to the amount of the SSI COLA for the first quarter of the year.

## Proposed Changes for CY2007 and CY2008

On January 10, 2006, California Governor Arnold Schwarzenegger unveiled his proposed state budget for FY2006-FY2007. Included in this budget is a proposal, that, if adopted by the legislature and signed into law, would extend the CY2007 cuts in the state SSP supplement until July 2008 rather than ending these cuts after the first quarter of 2007.<sup>7</sup>
