## Introduction

May is Asian/Pacific American Heritage Month. It is a time to recognize the contributions and achievements of Americans of Asian, Native Hawaiian, and Pacific Island descent.

This guide is designed to assist congressional offices with work related to Asian/Pacific American Heritage Month celebrations. It contains links to census and demographic information, CRS reports, and presidential proclamations, as well as additional web resources commemorating Asian/Pacific American Heritage Month. The guide also provides a list of educational, cultural, and advocacy organizations focusing on the Asian/Pacific American community.

## History

President Jimmy Carter declared May 4-10, 1979, Asian Pacific Heritage Week, as called for by the passage of P.L. 95-419. The observance was extended to one month by P.L. 101-283, signed by President George H. W. Bush in 1990. In 1992, Congress passed P.L. 102-450, which permanently designated May as “Asian/Pacific American Heritage Month.” The commemoration also is referred to as “Asian American and Pacific Islander Heritage Month,” as seen in Presidential Proclamation 8369 of 2009, and as “Asian American, Native Hawaiian, and Pacific Islander Heritage Month” in recent presidential proclamations and congressional commemorative statements and presidential proclamations.

## Legislation

P.L. 102-450 is codified in the *U.S. Code* at 36 U.S.C. §102.
