

## **State Criminal Alien Assistance Program** (SCAAP): Data Brief

February 27, 2025

he State Criminal Alien Assistance Program (SCAAP) is a payment program that reimburses states and localities for correctional officers' salary and training costs incurred for incarcerating "undocumented criminal aliens." States and localities can only use SCAAP funds for "correctional purposes."

The Immigration and Nationality Act (INA) defines the term "undocumented criminal alien" in the context of SCAAP to mean an alien<sup>2</sup> who

has been convicted of a felony or two or more misdemeanors; and

- (I) entered the United States without inspection or at any time or place other than as designated by the Attorney General;
- (ii) was the subject of exclusion or deportation proceedings at the time he or she was taken into custody by the State or a political subdivision of the State; or
- (iii) was admitted as a nonimmigrant and at the time he or she was taken into custody by the State or a political subdivision of the State has failed to maintain the nonimmigrant status in which the alien was admitted or to which it was changed under Section 248, or to comply with the conditions of any such status.<sup>3</sup>

Any state or locality that incurred reimbursable costs for incarcerating undocumented criminal aliens is eligible to apply for SCAAP funding. For states and localities to qualify for SCAAP reimbursement, aliens under their jurisdiction must have at least one felony or two misdemeanor convictions and be incarcerated for at least four consecutive days.

SCAAP was created by Section 20301 of the Violent Crime Control and Law Enforcement Act of 1994 (P.L. 103-322), and it is currently codified at Section 241(I) of the INA. The program is administered by the Bureau of Justice Assistance (BJA), which is part of the U.S. Department of Justice's (DOJ's) Office of Justice Programs (OJP). The U.S. Department of Homeland Security (DHS) aids BJA in administering the program.

This data brief provides information on SCAAP awards by state and U.S. territory for the last 10 fiscal years (FY2015-FY2024).
